understand and agree that, under the *National Vocational Education and Training Regulator (Data Provision Requirements) Instrument 2020*, Australian College Pty Ltd is required to collect personal information (information or an opinion about me), collected from me, my parents or guardian, such as my name, Unique Student Identifier (USI), date of birth, contact details, training outcomes and performance, sensitive personal information (including my ethnicity or health information) and other enrolment and training activity-related information (together 'Personal Information') and disclose that Personal Information to the National Centre for Vocational Education Research Ltd (NCVER).

My Personal Information (including the personal information contained on my Enrolment Form and my training activity data) may be used or disclosed by Australian College Pty Ltd for statistical, regulatory and research purposes. - Issuing a VET Statement of Attainment or VET Qualification, and populating Authenticated VET Transcripts;
- · Facilitating statistics and research relating to education, including surveys;
- Understanding how the VET market operates, for policy, workforce planning and consumer information;

- Administering VET, including program administration, regulation, monitoring and evaluation.

I may receive an NCVER student survey which may be administered by an NCVER employee, agent, or third party contractor. I may opt out of the survey at the time of being contacted.

NCVER will collect, hold, use and disclose my Personal Information in accordance with the Privacy Act 1988 (Cth), the VET Data Policy and all NCVER policies and protocols (including those published on NCVER's website at www.ncver.edu.au)

The Department may disclose my Personal Information to other Australian government agencies, including those located in States and Territories outside New South Wales.
